OUR SPEAKERS



TED GRAHAM

Head of Open Innovation at General Motors. Author, 'The Uber of Everything'. Ted works with outside partners to solve important issues that will shape the future of transportation. Previously, he was the Innovation Leader at PwC Canada where he helped to turn ideas into invoices. He is also founder of the South Core Innovation Hub, a collaborative group of innovation leaders from Toronto's unique waterfront area. Member organizations include large banks, startups, public transportation – all of whom are looking to make a substantial impact on their communities. Prior to PwC Ted was a McKinsey strategy consultant with a focus on understanding and leveraging people networks to influence the spread of ideas.

SENATOR MOBINA S.B. JAFFER

Senator Mobina Jaffer represents the province of British Columbia in the Senate of Canada. Appointed to the Senate on June 13, 2001, she is the first Muslim senator, the first African-born senator, and the first senator of South Asian descent. Senator Jaffer is Deputy-Chair of the Standing Senate Committee on National Finance, and sits as a member of the Legal and Constitutional Affairs committee, National Security and Defence committee, and the Official Languages committee. Senator Jaffer also chaired the Standing Senate Committee on Human Rights for 8 years.



JEAN-FRANÇOIS PERRAULT

Jean-François Perrault joined Scotiabank in 2015 as Senior Vice President and Chief Economist. He leads a team of Economists to support Scotiabank's domestic and international business lines and clients from retail to capital markets, providing Scotiabank's senior executives, business lines and customers with perspectives, insights and forecasts on economic, financial market and policy developments. Prior to joining Scotiabank, Jean-François held prominent roles with the federal government, the Bank of Canada, the International Monetary Fund and the World Bank.

CAROL MASON

Carol Mason is retiring this year as the Chief Administrative Officer of Metro Vancouver. Since she started working in local government in 1991, Mason has held a variety of positions, including at the management level within the city and regional district of Nanaimo. She will speak about her experiences at the senior level of municipal government and the critical relationship between the CAO and the finance department.



SHAYNE KAVANAGH

Shayne Kavanagh is the Senior Manager of Research for GFOA and has been a leader in developing the practice and technique of long-term financial planning and policies for local government. He started GFOA's long-term financial planning and policy line of research in 2002 and has been working with governments on financial planning and policies ever since. He is the author of a number of influential books on financial planning in city government. His forthcoming book, Financial Foundations for Thriving Communities, takes a Nobel Prize winning body of work about how to sustain commonly owned natural resources and applies it to a community's commonly owned financial resources: the public budget.
